Dear Artisan, Crafter or Independent Consultant Vendor:

ACE Promotions proudly presents 'Christmas in the Park,' Saturday, November 16, 2024. From 10 a.m. to 3 p.m., the event will be a vendor market and will include pictures and visits with Mr. and Mrs. Santa, performances of some of the area's best church and school choirs, food vendors, a live nativity and other great opportunities for family fun. At dark, the park will be illuminated to complete the holiday atmosphere. Many more activities, entertainment and photo opportunities will abound. Each vendor space will measure 12 x 12 and there will be limited electricity available, which will be assigned on a first-come, first-served basis.

<u>Fee:</u> The early bird registration fee is \$100 per site for crafters, independent consultants, artisans and organizations. Vendors wishing to take advantage of the early bird fee must register no later than **October 15, 2024.**

After Oct. 15, the fee goes up to \$125. Make checks payable to: "ACE Promotions"

Please complete and mail registration form with payment to: ACE Promotions, ATTN: Christmas Vendor, P.O. Box 852, Amelia, VA 23002. Alternatively, vendors may register online at <u>www.acepromotions23002.com/christmas-in-the-park</u>. Registrations will not be processed without receipt of payment.

Space: The booth space is 12 x 12 feet.

Location: We will email you booth map and your booth number. We cannot guarantee locations on the square, although you may make requests, which attempts will be made to honor. Booths are assigned on a first-come, first-served basis.

<u>Equipment:</u> Limited electricity is available and vendors will need to provide 100 ft. extension cords and for consumer safety, a means to cover the cord if it crosses a walkway. Quiet generators will be allowed so long as noise does not interfere with the onstage entertainment. If shade is essential, vendors should bring their own canopies, tents or umbrellas. Please bring the necessary equipment to anchor anything that you may bring. Vendors must supply their tables and chairs. Please be sure that everything you bring will fit into your assigned 12x12 foot space as anyone who invades another vendor's space may be asked to leave. You are responsible for any additional permits that may be needed to vend (i.e health permit, ABC license, etc.).

<u>Time:</u> Set up is from 7 a.m. until 9 a.m. Times will be staggered based on where your booth is located. You may drive to your booth during this time to drop off your wares/equipment, but all cars must be off the vending area by 9:45 a.m. Take down is after 3 p.m. Only after 3 p.m., will you be allowed to drive back to your booth and be clear of the area by 5 p.m.

<u>Weather:</u> There **is no rain date for this event** in the event of inclement weather. Advance cancellation will be announced on the ACE Promotions Facebook pages and website.

<u>Procedures:</u> We understand that you want a booth because you are passionate about your cause or event, craft or product, but we ask that you stay with your booth and not wander the crowd with literature. We have had past complaints about aggressive solicitation.
